Neighborhood Watch presentation scheduled -- AMHA Annual Meeting Set for Tuesday, Nov. 3

A deputy from the Champaign County Sheriff's department will be the featured speaker at the Arbour Meadows Homeowners' Association (AMHA) annual meeting, set for Tuesday, Nov. 3.

The meeting will begin at 7 p.m. at the Savoy Municipal Center, corner of West Tomaras St. and Dunlap Ave. (Rt. 45).

The Sheriff's deputy will talk about Neighborhood Watch programs, and will be available to answer resident questions about crime prevention and police protection within the Village of Savoy.

Other topics on the agenda will include the annual financial update for AMHA, and the impact of recent Village of Savoy

public- works projects that will affect drainage and traffic patterns in and around the neighborhood.

Election of AMHA Board members and officers also will take place. If you are interested in serving on the board, call 351-4092. Nominations from the floor will be accepted during the meeting, as well.

Update your information now! New Neighborhood Directory Coming Soon

AMHA Board members are in the final stages of compiling the 2009-2010 Neighborhood Directory – and this is “last call” for updated household listings. **New and updated listings are due by Wednesday, Sept. 30**

Listings typically include the names of adults in the household, the street address, a phone number and names of any children in the household. However, phone numbers and/or children's names may be withheld upon request.

If no information is submitted for a particular address, the directory listing will include the name of the owner of record as of last spring (when annual assessment bills were mailed out).

Although email addresses are solicited on the household information forms, they will not be published in the directory this year. Any email addresses collected will be used only by the AMHA board for distribution of newsletters and other

official communications.

New listings may be submitted, and existing listings may be updated, on the AMHA website, at www.dspgweb.com/amha To submit or update your information, click on **directory** and then the **web form** link.

Directories will be distributed within the neighborhood this fall.
